


**Announcement
on conducting open tendering**

- 1) **Name, location and identification number of the Customer in the Ukraine Register of Legal Entities, Individual Entrepreneurs and Public Associations, its category:** MUNICIPAL INSTITUTION «CENTER OF THE INTEGRATED VIDEOSURVEILLANCE SYSTEM AND VIDEOANALYTICS OF THE CITY OF ODESSA (CENTER –«077»); house 67-A, Raskidaylovskaya street, Odessa, 65006, Ukraine; 23211998; legal person, which keep up needs of the State and territorial community.
- 2) **Name of the subject of procurement with indication of the code according to the Unified Procurement Dictionary (in case of division into lots such information must be indicated for each lot) and names of relevant classifiers of the subject of procurement and parts of the subject of procurement (lots) (if available):** Technical maintenance of the integrated videosurveillance system and videoanalytics of the city of Odessa for 2023 year code according to the Unified Procurement Dictionary 021:2015: 50340000-0 - repair and technical maintenance services of audio-visual and optical equipment.
- 3) **Quantity and place of delivery for goods, volume and place of works execution or provision of services:** 1 (one) service; Ukraine, in accordance with the Documentation.
- 4) **The expected value of the object of tender:** 11 000 000, 00 UAH.
- 5) **Term of delivery for goods, works execution or services provision:** till to December 31, 2023.
- 6) **The deadline for submission of tenders:** till 10 (ten) o'clock November 21, 2022. ✓
- 7) **Terms of payment:** Event – Services provision; Description – Payments should be made in Ukrainian hryvnias, in accordance to payments schedule for provided services of Technical maintenance of the integrated videosurveillance system and videoanalytics of the city of Odessa for 2023 year (Annex No.3 to Service Agreement), only in case of receipt budget financing by Customer. Any payment should be made by Customer in accordance to code 2240 of Economic classification codes for budget expenditures «Payment for services (except public services)». Payment for each month for provided services of technical maintenance of the integrated videosurveillance system and videoanalytics of the city of Odessa for 2023 year should be made by Customer not later, than 15 day of next month in accordance to Act of acceptance and transfer of services rendered, and only in case of receipt budget financing by Customer; Type of payment – payment in arrears; Period (days) – 15; Type days – Calendar days; Size of payment, (%) – 100.
- 8) **Language (s) in which tender proposals should be prepared:** Ukrainian.
- 9) **The size, type and conditions of providing security for tender proposals (if the customer requires it):** is not required.
- 10) **Date and time of opening of tender offers, if the announcement of open bidding is published in accordance with part three of Article 10 of the Law:** Filled automatically by tenders electronic system.
- 11) **The size of the minimum step of lowering the price during the electronic auction in the range from 0.5 percent to 3 percent of the expected purchase price or in monetary units:** 0,5 % of expected price of tender.
